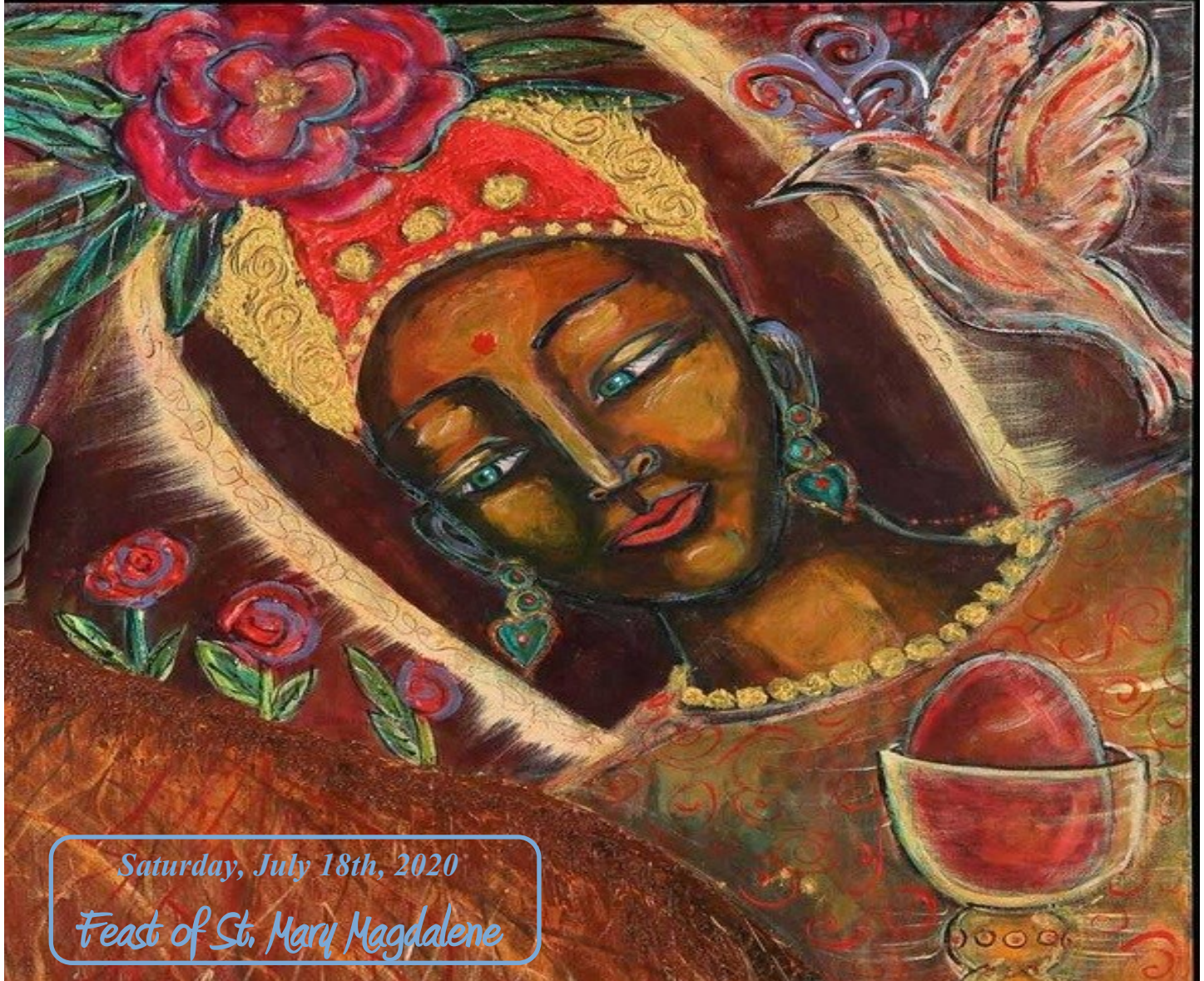

"I have seen the Lord."

As we celebrate the feast day of St. Mary Magdalene this coming weekend, we remember how she was the first person the Risen Christ appeared to, becoming the apostle to the apostles. May we too hear God call us beloved and respond with courage to share the Gospel message with the world.

Here's what's happening these days at LOC:

- **Email Fraud** ~ If you receive an email from Fr. Teri asking for a favor or for money, it is a scam. Delete it. We are working on ensuring that these fraudulent emails cannot reach our community anymore.
- **Prayer Companions** ~ When we have liturgy in the sanctuary, we let folks know that our LOC Prayer Partners are available after Mass for you to listen to what's on your heart or pray with you. That pastoral care team wants you to remember that they are still here for you! They want to provide prayer and support for you in your times of need. Their work does not in any way replace your ability to reach out directly to Fr. Teri; they only complement the pastoral care that she currently provides. If you would like to connect with these pastoral care ministers, email prayercompanionteam@lightofchristecc.org, and one of them will reach out to you.
- **Watching Mass Online** ~ Remember, if you can't watch Mass online until after the Live broadcast at 5pm on Saturday nights, you can always go to the LOC website and under the tab "Facebook Live Masses," there's a clear, chronological list of each Mass with their respective FB links. You can access that page of our website [here](#).
- **Communion Porch Drop** ~ On Sunday, July 19th we will be doing another Communion porch drop. We will consecrate enough hosts at Mass the night before for everyone to have some at home if you live locally, and our Porch Drop Team will help us get the hosts to you. This porch drop is one that you need to "opt in" for, and tell Fr. Teri that you want someone to bring you the hosts. To do that, please send an e-mail to pastor@lightofchristecc.org by Wednesday, July 15th. Use "Communion" as the subject, and in the e-mail please note how many people in your home would like Communion, and if you need gluten-free. However, if you received Communion at our last Porch Drop, you are already considered "opted in," and you do not need to do that again. On July 19th, someone will contact you to bring you Communion and leave it in a bag on your porch. We ask that you and the porch drop delivery person coordinate so that at the porch drop you at least make eye contact with each other and we know the Communion has arrived safely to you. In addition, please create a sacred little space in your home to serve as a home Tabernacle to keep these hosts. They will last you a couple of weeks. This sacred space could be as simple as a piece of cloth. We look forward to providing everyone who lives locally this opportunity to receive Communion.
- **Local Bishop Call Process** ~ As you may remember, we were in the process of calling a local bishop earlier this year when the pandemic changed our plans. We want to let you know that the bishop call team is going to start meeting again via Zoom to help our region move forward again. We have introduced a new prayer that everyone in the region is invited to pray, that God's Spirit may guide us and that we may hear that guidance and respond. If you have any questions, you can check with Fr. Teri, or Annie or Mary Lu, as they serve on the local bishop call team. Please watch the bulletin for further information as we anticipate moving into the stage of nominating candidates in the next few months. Here is the prayer we are invited to pray together:
